Bids must be submitted on EPADS on or before **Feb 09, 2026 at 1400hrs** along with Bid Security for an amount of Rs. 50,000/- (Rupees Fifty Thousand only) in the name of National Engineering Services Pakistan (Pvt.) Limited. Bid Security of successful bidder shall be released after successful delivery, while of unsuccessful bidders shall be returned after award of work.
